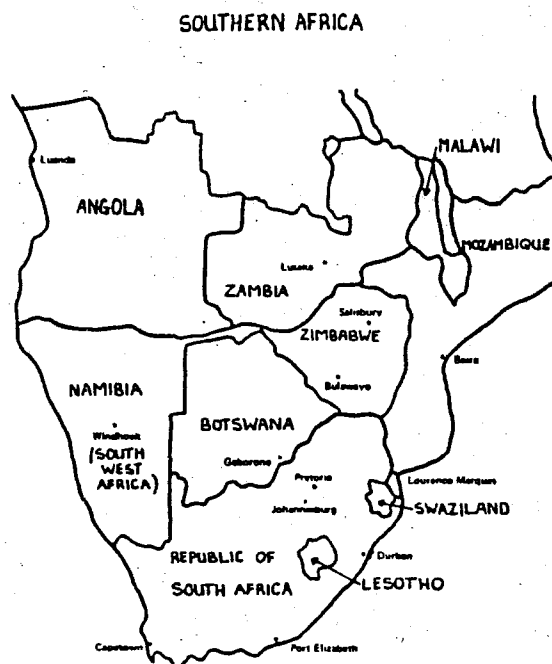
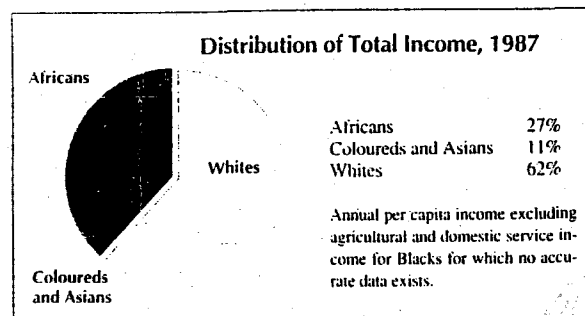
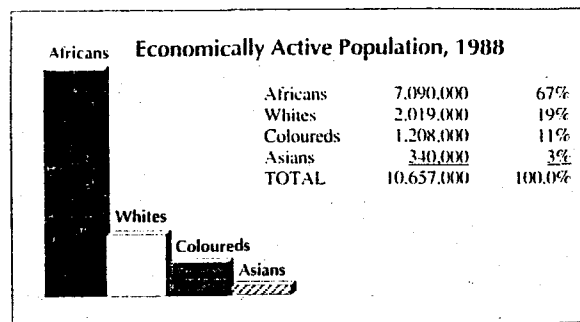

BACKGROUND

The Delaware Committee Against Racism and Apartheid is a multi-racial group of religious and community leaders and concerned individuals committed to the abolition of apartheid, and of racism wherever it occurs.

The committee was formed in 1985 as the Delaware Committee for a Free South Africa. The name was changed in 1989.

The committee played a leading role in the passage of an ordinance for divestment by the New Castle County in '86 and in banning South African imports from the Marine Terminal in '87.

It has sponsored workshops and film showings, rallies, public speakers and press briefings on Southern Africa and the policy of the United States towards the apartheid regime.

Under the auspices of the Delaware Teachers Center, it has conducted yearly classes about apartheid.

In 1990 DCARA held its first annual Artists Against Apartheid week-long festival, with the commemoration of SOWETO Day, June 16, as the focal point.

PURPOSE

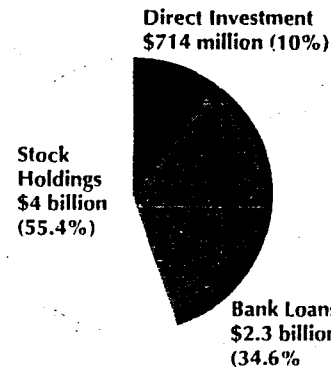

To organize and promote public witness and action for a free, democratic, non-racial society in South Africa and the United States.

To work for racial justice in our own communities and in the domestic and foreign policies of the United States.
